
PROGRESS REPORT

This pertains to the investigation being conducted by this office relative to a Drug Buy- Bust operation turned into a shooting incident conducted by elements of SAID-SOTU PS-6, MPD that resulted to the death of fatalities (1) LEO GELUZ y MERCED, (2) JOSHUA MERCED y MERCED and (3) BIMBO MERCED y SIPRANO. Said incident occurred on January 25, 2017 at about 3:00 AM inside house no. 2565 Benita Compound Paisig Line Zobel Roxas Sta. Ana, Manila. (MPD PS-6 AOR)

On February 9, 2017 at around 11:40 PM, AMINA MERCED y SOFRANES, 47 years old, single, housewife, mother of fatalities nos. 1 and 2 and sister of fatality no 3, presently residing at house no. 2565 Benita Compound Paisig Line Zobel Roxas Sta. Ana, Manila appeared to this office and submitted photocopies of Certificates of Death with registry nos. 2017-001522 and 2017-001523. Based from said documents the real name of the fatality no 2 was JOSHUA MERCED y SOFRANES while fatality no. 3 was BIMBO MERCED y SOFRANES contrary to the name previously reflected in the spot report dated January 25, 2017.

Moreover, AMINA MERCED y SOFRANES signified her intention to rectify the name of his son as earlier read JOSHUA MERCED y MERCED to read as JOSHUA MERCED y SOFRANES also earlier read as BIMBO MERCED y SIPRANO to read as BIMBO MERCED y SOFRANES.



JOINT AFFIDAVIT OF COMPLAINT

We, the undersigned police officers, all of legal age, bona fide members of the SAID – SOTU of Police Station 6, Sta. Ana Police Station, Manila Police District, Plaza Hugo Sta. Ana Manila, after having been duly sworn to in accordance with law hereby depose and state.

1. That at about 3:00 a.m. of January 25, 2017 at house number 2565 located at Benita Compound Pasig Line Sta. Ana Manila. We conducted a buy-bust operation against the suspects identified as to wit.

S-1 JOSHUA MERCED y MERCED, @ Owang, male, 22 years old, construction worker, residing at 2565 Benita Compound Pasig Line Sta. Ana Manila, for a case violation of R.A 9165 Comprehensive Dangerous Drugs Act of 2002, Section 5 Sale of Dangerous Drugs in relation to Section 26 Attempts or Conspiracy and R.A 10591 Comprehensive Law on Firearms and Ammunition.

S-2 LEO GELUZ y MERCED, @ Leo, male, 25 years old, jobless residing at 2565 Benita Compound Pasig Line Sta. Ana Manila, for a case violation of R.A 9165 Comprehensive Dangerous Drugs Act of 2002, Section 26 Attempts or Conspiracy in relation to Section 5 Sale of Dangerous Drugs and R.A 10591 Comprehensive Law on Firearms and Ammunition.

S-3 BIMBO MERCED y SIPRIANO, @ Cris, male, 37 years old, jobless residing at 2565 Benita Compound Pasig Line Sta. Ana Manila, for a case violation of R.A 9165 Comprehensive Dangerous Drugs Act of 2002, Section 26 Attempts or Conspiracy in relation to Section 5 Sale of Dangerous Drugs and R.A 10591 Comprehensive Law on Firearms and Ammunition (All Deceased) committed as follows.

2. That prior to the buy-operation, rampant proliferation and sale of dangerous drugs particularly shabu was received by the office of chief SAID-SOTU. Perpetrated by "MERCED GANG" (Drug Group) coming from Barangay 778, Zone 85, District V, Manila, under the jurisdiction of Barangay Chairman Vergilio P. Dacara Jr. (Hereto Attached Barangay Certification) further it was validated by the Intelligence Section of this Station led by PSI Consorcio Pangilinan (Hereto Attached Intelligence Information Report).

3. That after confirming the said information PSI Alfredo Tan Jr., relayed the information to our station Commander Police Superintendent JERRY CORPUZ, and tasked our team to conduct buy-bust operation to stop the nefarious drug trade activities of the "MERCED GANG" (Drug Group).

4. That prior to the actual buy-bust operation, a briefing was conducted by Chief SAID-SOTU PSI Alfredo Tan Jr., in which PO3 Allan Escramosa, was tasked to act as police poseur buyer, two (2) pieces of dusted one hundred peso bills was supply to him to be used as a buy-bust money with markings AVT-7 and AVT-6. Also coordination to Manila Police District Headquarters, was made to obtain from PDEA the Authority to Operate and Pre-Operation Report with control number 10001-012017-0624 indicating the alias of target persons. (Hereto attached photocopy of the dusted marked buy-bust money, Authority to Operate and Pre-Operation Report coming from the Philippine Drug Enforcement Agency PDEA).

5. That at about 2:25 a.m of the same date the undersigned together with the confidential informant proceeded to the target area. While the back-up team members positioned themselves strategically in the safe distance and then follow the direction and movements of the designated police poseur buyer.

6. That the police poseur buyer PO3 Allan Escramosa, together with the confidential informant proceeded to the target house at 2565 Benitz Compound Pasig Line Sta. Ana Manila. In which both of them were approached by a male person standing in front of the door of the same house wearing orange sando and black sporting short with tribal tattoo on his left arm. Also introduced himself as @ Leo, known drug personalities in Barangay 778, also included in the watched list of Sta. Ana Police Station. (Hereto Attached Drug Watch List of Sta. Ana Police Station).

7. In which after a brief conversation asked the tandem of police poseur buyer and the confidential informant in vernacular "KUKUHA BA KAYO NG ITEM PARE." I (PO3 Allan Escramosa) the designated police poseur buyer also replied in vernacular "PARE KUKUHA KAMI HALAGANG TWO HUNDRED PESOS LANG."

8. Thereafter @ Leo, later identified as LEO GELUZ y MERCED invited us to come inside the house. And upon entering in the said house we notice @ Cris later identified as BIMBO MERCED y SIPRIANO and @ Owang later identified as JOSHUA MERCED y MERCED, sitting on the floor talking to each other. Both were also known drug personalities of the same Barangay and included in the watch list of Sta. Ana Police Station.

9. @ Leo told @ Cris and @ Owang "KUKUHA DAW SILA NG ITEM TWO HUNDRED PESOS LANG" @ Owang stood-up and pulled out a coin purse tucked from his right waist line comprising of undetermined number of small heat sealed transparent plastic sachets containing white crystalline substance of suspected to be shabu. And directed the police poseur buyer to choose one.

10. Thus I (PO3 Allan Escramosa) select one (1) piece of small heat sealed transparent plastic sachet. After scrutinizing and confirming that it contain white crystalline substance of suspected to be shabu later with markings JM-1 1/25/17. I put it safely to the right front pocket of my maong shorts.

11. Subsequently @ Cris stood-up and asked the money as payment for the the stuff or shabu. I (PO3 Allan Escramosa) the police poseur buyer handed to @ Cris, the dusted marked buy-bust money consisting of two pieces of one hundred peso bills. Upon receiving the marked buy-bust money @ Cris put it safely to the right front pocket of his short pants.

12. Afterwards @ Leo and @ Owang went outside the house. However, both suspects notice the presence of the back-up operatives PO2 Francisco Mendoza and PO2 Roestrell Ocampo, near the target house. And then immediately pulled out their unknown caliber of firearms and shot towards the direction of the police officers while they were about to fled stepping backward inside the house shouting on top of their voice "MAY MGA PULIS CRIS."

13. Both police officers sensing that their lives were in eminent danger, retaliate and shot both suspects to disable the same using their issued firearms. As a result suspects @ Leo and @ Owang sustained gunshot wounds and collapsed on the ground.

14. On, the other hand I (PO3 Allan Escramosa) the designated police poseur buyer having a brief conversation inside the house with the suspect @ Cris. When he heard the gunshot and scream outside of the same house. @ Cris, immediately pulled out his unknown caliber of firearm tucked and concealed in the right waist line of his shorts and shouted in vernacular "PUTANG INA MO PULIS KA PALA PAPATAYIN KITA" and then shot the police poseur buyer (PO3 Allan Escramosa) but he missed.

15. I (PO3 Allan Escramosa) feel that my life was in eminent danger retaliate and shot the suspect @ Cris using my issued firearm to disable him.

16. Thereafter the wounded suspects were rushed to Sta. Ana Hospital, for medical treatment on board on the mobile car. However, later pronounced dead on arrival (DOA) by the attending physician Dr. Michael Galves and Dr. Blas Yu.

17. I (SPO1 Dante Surban) designated as Station Anti Illegal Drugs Special Operatrion Task Unit, investigator confiscated from the crime scene one (1) unit of caliber 38 revolver with out serial number marked with JM 1/25/17, six (6) pieces of caliber 38 live ammunitions with markings JM-1, JM-2, JM-3, JM-4, JM-6 and JM -7. One (1) unit of caliber 22 revolver with out serial number marked with BM-1 1/25/17, two live ammunitions of caliber 22 marked with BM-1 and BM-2, two (2) empty shell of caliber 22 marked as BM-3 and BM-4. One (1) improvised shotgun "SUMPAK" marked with LM 1/25/17 and one (1) piece live ammunition of twelve gauge shotgun. And sixteen (16) pieces of small heat sealed transparent plastic sachets containing white crystalline substance of suspected to be shabu later with markings JM-1, JM-2, JM-3, JM-4, JM-5, JM-6, JM-7, JM-8, JM-9, JM-10, JM-11, JM-12, JM-13, JM-14, JM-15 and JM-16 respectively all with date and signature of the respective seizing officer. (Hereto attached inventory and photographs of the confiscated pieces of evidence)

18. The said pieces of evidence were confiscated from the possession and control of the suspects, later identified as JOSHUA MERCED y MERCED, @ Owang, BIMBO MERCED y SIPRIANO @ Cris and LEO GELUZ y MERCED @ Leo (All Deceased).

19. The proper markings, inventory and photographs of the confiscated pieces of evidence were also made at the office of PS-6 SAID-SOTU. Likewise being witness by Barangay Kagawad Ciriaco Ladera Jr. and Barangay Executive Officer Benancio Abanilla of Barangay 778, Zone 85, District V, Sta. Ana Manila. In compliance with Section 21 of Republic Act 9165. (Hereto attached photocopy of the Reciept and Inventory of Property Seized also the Chain of Custody).

20. I (SPO1 Dante Surban) directly turn-over the confiscated pieces of evidence to MPD Crime Laboratory Field Office for laboratory examination.

21. It was received and in the custody of PSI AILLEN V YAGONO, Forensic Chemist, later gave positive result to the test for Methamphetamine Hydrochloride a dangerous drug. While the firearms and ammunitions were received and in the custody of SPO1 Cortes G.A respectively. (Hereto attached photocopy of the result of crime laboratory examination)
